CAUTION: Adolescents at risk

Jane and I first met Craig Crawford at President-Elect Tom Coordingly's home in Helena. Tom was assembling his new Board Team and, though the Helena KC had been around for nearly 90 years, Tom wanted to look at its service work with new and re-focused eyes. Enter Craig. Craig, at the time, was the Principal at the "P.A.L." high school in town — "Project for Alternative Learning." Travis Brazill, a member of the Helena Kiwanis Club and a local banker, had somehow struck-up a relationship with Craig. As a result of their newfound friendship, Brazill shortly thereafter had no problem selling Coordingley on what he saw, and what proved to be, a great new opportunity for service work — a partnership between HKC and P.A.L. Ah, but I'm getting ahead of myself ...

P.A.L. is a stand-alone *alternative* high school in Helena – one of a very, very few across the 150+ fiercely independent school districts in Montana. (Most of the "alternative high schools" are actually part of communities' existing high schools, though with curriculum that differs from school to school.) I didn't even know we had such a school in Helena. I *did* have an image in my mind about "alternative" high school students though and, truthfully, it wasn't glamorous. What I didn't know when I went to Tom's house that night was that Craig was about to shatter my stereotypes and prejudices. He did that with the precision of a skilled surgeon and, once completed, I became a "true believer" in these kids.

Craig began to describe kids who, for whatever reasons, simply do not fit into the *conventional* high school environment – schools like Helena High, Skyview High, Sentinel High – you know, *normal* high schools. I used to think, when I was prisoner to my stereotypes, that these were the misfits and that's why they didn't fit in. Ok, maybe there are a couple for whom that description applies. But the vast majority cannot be so easily nor so negatively labeled with stereotypes. Some come from homes so broken it defies one's imagination. Others have no home – *they are homeless*. Others have a maturity so far exceeding their conventional high school counterparts that they are already building their academic futures: they require a customized, hybrid curriculum with no frills attached and less time in the classroom (so they can spend more time working to save \$ for college). Trust me, folks – this is the tip of the iceberg when it comes to why many of these kids opt for an alternative school.

Ok, Gov – just where are you going with all of this?

Anyone familiar with Key Club knows that it is Kiwanis International's home run, its Poster Child, its raving success story – in spades. There are more Key Clubbers throughout the world than there are Kiwanians. It is by far the largest high school student group in the world bar none. Get the picture?

Key Club, which emerged into the Kiwanis picture in 1925, has been a HUGE success since. **It is long overdue to bring the success Kiwanis has enjoyed among Key Clubbers to high school students outside of the conventional high school setting – these at-risk kids.** And we can do it. We can apply our huge repertoire of success with conventional students in Key Club to those we have, quite frankly, overlooked *for decades*.

And that's just what the Montana District is attempting to do. Montana is breaking new ground in International by directing some (not all) of our energy and resources on to these at risk kids. Heather Denny, from the Office of Public Instruction (OPI) who works directly with school administrators across the state with these at-risk high school students, gave a powerful presentation on Feb. 23rd at Mid-Winter Conference, followed by an even more insightful workshop. Heather shared a wealth of information about these kids – who they are (and are not), and how Kiwanis can make a powerful impact upon their young and vulnerable lives. Heather's videotaped keynote address and workshop will soon be posted on our District website, www.montana.kiwanisone.org. Where have they gone?






We *don't* want *any* kid to crash & burn

Our K-Family organization is the greatest such organization in the world. We are already impacting young people through service and through SLP development. I want this to continue far into the future, and it can, but we need your help.



A preface to the "Coverage Corner" by Governor Chuck:

I am most appreciative of John Menyhart providing the informative document below. It is a *must read* for leaders and advisors of Kiwanis Club sponsoring Service Leadership **Programs – especially Key Club.** It is an important read for all other Kiwanians as well – and, again, especially leaders.

John has served many years as the Risk Manager for the Montana District. John is a professional in the insurance industry whose agency is in Miles City. He recently presented this information at a workshop at Mid-Winter Conference in Helena – a workshop co-presented with our new District Key Club Administrator, Dean Person. Then in March, this material was provided to Kiwanis and Faculty Key Club Advisors at Key Club's "DCON" [District Convention] in Billings.

John offers both technical and common sense guidance on how parents and Kiwanis Clubs can enhance the safety of these young people, as well as minimize their own financial risks, related to transportation issues. Bullet points include:

- Assume there is NO Kiwanis insurance coverage when Key Clubbers drive themselves to and from Kiwanis events
- There are valid concerns of parents, advisors, school administrators, and Kiwanis Clubs which relate to those whom our children's transportation is entrusted to.
- ♦ Insurance has a language of its own and it can be complicated, if not downright confusing.

COVERAGE CORNER

This issue: Use of Automobiles in Kiwanis Activitie

Many times the need arises for Kiwanians to use automobiles to conduct Kiwanis activities. This could involve transporting Key Club members to a conference, taking children to a Kiwanis camp or outing, delivering Meals on Wheels, etc. Therefore, it is important for Kiwanians to understand what coverage is afforded under the Kiwanis Commercial General Liability policy for these exposures.

We must first look at some basic definitions in order to fully understand how Kiwanis insurance coverage does or does not apply. For insurance purposes, and in simplistic terms, an *"owned auto"* would be *an automobile owned by a Kiwanis Club or Kiwanis District*. It could be a pickup truck owned by a Club that hauls the Club's concession stand or perhaps tows the Club's float in the 4th of July parade. It could also be a school bus used by a Club/District to transport children to and from a

Kiwanis camp. There is no coverage under the Kiwanis Commercial General

<u>Liability policy for owned autos.</u> If your Club or District owns a truck, bus, or automobile licensed for over-the-road use, then it must purchase a Commercial Auto Policy to provide Auto Liability Insurance required by the state, as well as Physical Damage coverage (Comprehensive and Collision) that the Club/District may want to carry on the vehicle.

A "non-owned auto" is an automobile that in not owned by a Club or District. Vehicles owned or borrowed by Club members would be considered "non-owned" autos under the Kiwanis Liability policy. The Kiwanis Commercial General Liability policy does provide Liability coverage for "non-owned" autos when used for Kiwanis activities. Coverage would apply on a Primary basis for the Club or District, and would serve as excess coverage over and above a Club member's personal Auto and Personal Umbrella policies. For example, if a Club member was using his/her personal auto on club business, had an at-fault accident, and he/she and the Club were sued by the injured parties, the Kiwanis policy would be primary and defend the Club, and would serve as excess (additional) coverage for the Club member (driver), but only after all his/her applicable personal insurance [Personal Auto policy and Personal Umbrella (if any)] were exhausted. The Kiwanis policy would not provide Physical Damage coverage (Comprehensive or Collision) for the Club member's damaged vehicle.

This Non-Owned Auto Liability coverage also includes coverage for "hired autos" defined as autos rented by a Club or District for use in Kiwanis activities. So if a Club borrowed a van from a local dealership, the Kiwanis policy would cover both the Club (on a Primary basis) and the club member driving the vehicle (on an excess basis), but it would not cover the dealership nor would it provide Physical Damage coverage (Comprehensive and Collision) should the van be damaged in an accident. Non-Owned and Hired Auto Liability coverage provides protection only for accidents involving Bodily Injury and Property Damage, and does not provide any Physical Damage coverage for the non-owned/hired auto. In this case the Club would want to make sure the Dealership was providing the Physical Damage coverage or else it would have to try and purchase that coverage from the Dealership, perhaps by means of a rental agreement..

If a Club/District were to charter buses for a Kiwanis activity, the Kiwanis policy would provide Liability protection for the Club/District relative to the vicarious liability incurred as a result of the charter—agreement. However, the Club/District should request the bus company to provide a Certificate of—Insurance evidencing Automobile Liability with a minimum limit of \$5,000,000 and naming the Club/District and Kiwanis International as Additional Insureds for the period of the charter. Additionally, the charter company should also be required to sign a Hold Harmless Agreement indemnifying Kiwanis for any liability arising out of their operations on behalf of Kiwanis.

MAJOR POINT: The use of autos in Kiwanis activities is a very common occurrence, but can pose a significant hazard in terms of potential for catastrophic losses. Extreme care should be taken to make sure all Kiwanians operating vehicles on Kiwanis business have a valid driver's license with no major violations in the last three years, and they carry adequate limits of insurance (\$500,000 Combined Single Limit Bodily Injury and Property Damage as a minimum). When using a charter company, \$5,000,000 limits are the suggested minimum and the Kiwanis club should obtain a Certificate of Insurance indicating they are named as an Additional Insured on the charter company's auto policy.

NOTE: Kiwanis Auto coverage is very limited to Hired(Rented or leased) & Non-owned Auto. Non-owned Auto only applies to <u>conducting the business of Kiwanis</u>. It applies to the Club Secretary driving to make a Kiwanis bank deposit or to the post office or a member picking up supplies for an Kiwanis event. Even when it applies, your "Personal Auto" policy is still 1st in line until limits are exhausted. Kiwanis Non-owned Auto is 2nd in line. Non-owned Auto <u>DOES NOT</u> APPLY TO A KIWANIS OR KEY CLUB MEMBER SIMPLY DRIVING TO A MEETING OR EVENT.

I would encourage parents to accompany their children to a Builders & Key Club events. If parents allows a student to driver; it is their prerogative and their sole responsibility. If they entrust their child to another driver, whether a parent or another teen, it would be wise to verify that the driver has a valid license, valid Insurance and adequate Insurance limits. If while driving the family car to a key Club event, a child gets in an negligent accident, the parents are legally responsible to the 3rd party and other occupants. If injuries and damage exceed your Insurance limits, you may be sued or have wages garnished. Be safe & choose wisely!!!

Note: the Non-Owned Auto Liability coverage afforded under the Kiwanis policy is **not** intended to cover club members or volunteers driving to or from Kiwanis activities or meetings, but rather only to cover them while they are actually on Kiwanis business of participating in Kiwanis activities.

On another front, I just wanted to give you a quick update on the world-wide Eliminate effort.



What about "B?"

The 1991 comedy, "What about Bob?" features Bill Murray playing Bob. Initially, Bob has issues – lots of issues. He tells workers in a mental hospital that his favorite poem is: "Roses are red, violets are blue, I'm a schizophrenic... and so am I!" Eventually, his self-absorbed psychiatrist, unable to manage Bob's episodes, cracks. Unexpectedly, as Bob begins to connect with others, he gets healthier and healthier.

Initially, Kiwanis had issues too. But, what health Kiwanis has demonstrated for decades.

"What about Bob?" has another connection with Kiwanis. Originally, our club was named BOB! That stood for Benevolent Order of Brothers. This old Detroit club was about to close. Three members approached an insurance salesman, Don A. Johnston, and asked him to shore up the club. Woody Allen makes jokes about following the advice of insurance salesmen. But, these men did and we are glad they did!

By 1915, they jettisoned their old name, BOB, and chose an odd Indian moniker – Kiwanis – meaning "we build." Maybe the word, "benevolent," was too awkward. But, for Don Johnston the meaning: bene – "good" + volent – "to wish, to will, to desire," expressed the heart of the organization. In other words, although "BOB" was gone, he was still asking his fellow club members: "What about "B?" – where "B" stood for Benevolence.

Such a purpose exposed underlying issues. As Kiwanis grew, there were two competing interests. Would the club's primary function be furthering business relationships – a "knife and fork dinner club" - or would they focus on serving others? They found that more than 60% of their members had joined Kiwanis to further their business connections and boost the bottom line. Early by-laws stated: There could be no more than four members engaged in competing lines of business. But, "What about 'B'?" Due to the leadership of Don Johnston, the "Golden Rule" group prevailed.

More than half the club left.

But Kiwanis continued to grow. These Golden Rule Kiwanians "adopted" a poor four and one half year old boy whose parents had divorced and were unable to care for him. The Kiwanians persuaded an elderly couple to provide foster care for this young boy. The Kiwanis club underwrote his expenses. The young boy was called: "Walter Kiwanis." Eventually, Walter's mother remarried. Her new husband was able to care for the boy so he was reunited with his mother in a new family. "B" was at work.

People in other cities were forming service clubs. They began to hear about this Detroit club. Within a year, there were 16 Kiwanis clubs in seven states. By 1917, Kiwanis became "national." And, now, Kiwanis is international.

So, you ask, "Pastor Steve, what's the point of this history?"

First, if we are to make sense of life, you and I need a sense of history. If we look only at the point where we are, we will see neither where we came from nor where we are going. Our early leaders in Kiwanis established our first two objectives:

To give primacy to the human and spiritual rather than to the material values of life.

To encourage the daily living of the Golden Rule in all human relationships.

The badge I was given a Chaplain for the Kiwanis Montana District gives my name and underlines <u>Human and Spiritual Values</u>. Now we know why!

Secondly, we can honor those who have gone before us by adopting these values – even if these values contradict the prevailing culture of our day. Consider the impact of various cultures on the good news of Jesus. Someone said that when Jesus came to the Jews, they tried to understand him according to their law. When he came to the Greeks, they tried to understand him according to their philosophy. When he came to Rome, they tried to make an empire out of him – and they did. When he came to America, we tried to make a business out of him – and we did. Still, God can give us the grace to go beyond the prevailing culture of our day so we can believe and act on the good news of Jesus.

Let's be leaders like Don Johnston. Let's keep asking: "What about 'B'?" Let's help each other serve all age groups – especially the young. Retreating into our own "little worlds" or only pursuing relationships with peers will stunt us. Kiwanis – "we build" – means: "We build bridges – particularly from one generation to another – even between Kiwanians and at risk kids."

Introducing Montana's Lieutenant Governor from Division 6

Bill Jones

snapshot of an incredible Kiwanian! by Chuck Amdahl

Bill Jones is a 4th generation Montanan who ranches on the family homestead nine miles outside of Harlowton.

"Harlow" is a small community boasting fewer than 1,000. At one point Bill and Debbie's family contributed five to this number, having three (now grown) children. They have been married for 41 years and are blessed with SIX grandchildren – but who's counting J Zach, their son, has gradually



assumed managing the ranch after graduating from MSU – just like Dad did a *few* years earlier. (Bill played football for the Cats – a career cut short with a serious injury his freshman year.) Bill decided that since, 'Zach has a lot more smarts and ambitions than I do, I just got out of his way and let him run the place!' Which parts of this are more true than others, I cannot be certain. But of this I am quite certain: "retiring" from full-time management of the ranch in no way resembles Bill being put out to pasture, or spending his days in a rocking chair on the front porch!

Bill joined Kiwanis in the late 70's-early 80's because – well, I think he kinda had to! After all, Great Grandpa Jones helped charter the Harlow KC, and each generation since had been Kiwanians in that club! That said, though, I really doubt Bill's arm was twisted to join. (If you know Bill, you'd realize how difficult it would be, if not suicidal perhaps, to try twisting his arm!) Bill puts community service through Kiwanis in this light:

"Public service is the rent you pay for the space you occupy in your community."

Hmmm. That's rather catchy, and very, very appropriate. What do you think?

Shortly thereafter, though, Bill had to take a sabbatical from Kiwanis until about 2000 as his family and ranching -and a whole bunch of other things – just got to be a bit much. Some of the "other things" Bill has been/continues to be very involved in include: Montana Farm Bureau (current Director); Humanities of Montana; Chamber of Commerce (current President); Hospital Board; School Board; Stock Growers Association – to name a few. Back in the Kiwanis saddle, Bill has been club President – as has Debbie – and decided to run for Lieutenant Governor, continuing to giveback not only to the community but to the District as well, now a seasoned veteran of the K organization.

Bill likes to read – a prolific reader, it seems, and on a wide diversity of subjects: science; space; Montana folklore and history; and others. He's also following in Grandma Jones' footsteps by extending her family genealogy research. Bill's education began in a little country school – that is, until he began going into Harlowton 'so I could be shared with all the others in town' J I'm not entirely sure what that meant, though I sense that Little Bill may have been a handful

I haven't been able to figure out just when Bill gets any sleep. From the sounds of it, maybe it's between about 2 a.m. - 4 a.m. every morning (if that much)....

Here's an anecdote from the Jones Folklore that you'll enjoy [used with permission, I might add!]: Bill began driving at the age of **4** yes, that's as in *four years old*! It seems the family had a Jeep, and young Bill – thinking it was never too young to start dating or, for that matter, driving ——

(it just gets better on the next page)

had a *girlfriend: Jesse*! Jesse lived a few miles away, the keys were in the Jeep, and the rest became part of the Jones' family folklore. Dad was combining at the time, and Mom was fit to be tied! "I got a lickin' when I got home!" Bill admitted – though, first, Jesse's family fed him before driving him back home to a very relieved - and undoubtedly a very annoyed! - mother. (There was no telephone to place a call of reassurance to Mom!) Grandpa Jones later suggested his son, Bill's father, remove the ignition key from the family airplane....

Family is all-important to Bill Jones. Listening to Bill, I would venture to add a close second: *the land*. Bill talks about the land with great affection, a real bond that comes from a lot of hard, hard work over a good number of years, generation upon generation. And I would venture a close third as well: Harlowton. The four generations of Jones' have been completely immersed and involved in their community. It runs in the Jones' blood, and it runs deep.

The big challenge facing Kiwanis nowadays is *membership* – keeping membership up. Sustaining a Kiwanis Club is the club's, and the community's, responsibility. Bill observes that this is precisely what Harlowton has done – and done very well, especially considering its size. The HKC's task is made a bit easier perhaps because it has its own building – the Kiwanis building. And the Kiwanis building gets used ALOT, drawing much attention because of its (Kiwanis') reputation for serving the community, and recognizing both individuals and organizations within Harlowton. Kiwanis is all over the place in Harlow, then – and that has kept it quite strong.

Bill doesn't have a "bucket list" per se. That said, though - and while Debbie and he have been coast-to-coast - there remain some sites in-between that they would like to see. To do that I suspect Bill will have to slow down a bit since, to use his own words: "I'm always on a mission!"

And knowing Bill Jones: he'd have it no other way!

Thank you, Bill, for making such an impact in and beyond your community - for *generations*.

This letter is a formal request of the Kiwanis Club you are serving to support a training opportunity for the young people of our District at the **Key Leader Event**, **August 16-18**, **2013**, **to be held at Glacier Bible Camp in Hungry Horse**.

This request is for all District clubs, regardless of whether the club you serve sponsors a Key Club or another Service Leadership Program, or already contributes in part or full to the Outreach Program. Clubs sponsoring a Key Club have a ready-made incentive to support this Key Leader Event. Clubs that do not yet sponsor a Key Club have a greater reason still: by supporting this event your members will become more directly involved in Kiwanis' primary mission: to help better the lives of young people.

Those involved with Key Club over the past several years know that there has been very little opportunity afforded our youth (through Kiwanis, at least) in terms of leadership training and personal growth opportunities. Those who go back further with Key Club remember that such opportunities had once been a stalwart feature of the Key Club experience. Key Leader provides both. At the District level of Key Club and Key Leader there is much excitement about this "new" opportunity! It is long overdue. It promises to re-enforce the good work already being done in Key Clubs throughout the District, and it can only expand our efforts to bring more high school students into Key Club. In other words, this is a win-win – for the kids, and for Kiwanis!

Key Leader costs - approximately two hundred dollars/student (without transportation). This expense is divided between the cost of the camp and food, as well as the time and transportation of a professionally-trained facilitator provided by Kiwanis International. Yet we have been successful in bringing that price down (including a gift to "seed" this event), so the cost per student is now about \$150.

There are different ways for your Club to support this event:

- Sponsor one or two high school students at \$150/student (an outright donation of \$150 \$300)
- Donate a sum equal to the number of your club's members X \$12 (which = \$1/month/registered member)
- For Clubs near Glacier, provide logistical support (talk with Betsy about this option, please)
 Help identify students in your community whom your club wants to sponsor. (Again, these students do NOT have to be in Key Club; neither does your Kiwanis Club need to sponsor a Key Club to participate in this.)

Requested method of payment:

Please make your club check payable to: "Kiwanis District of Montana" with a memo, "Key Leader Event," and mail to: "Mary Brydich, District Secretary/Kiwanis Dist. of MT, 102 Jackson Ln., Belgrade, MT 59714." If your club is sponsoring certain students, <u>please add their names to the memo line as well</u>. If a student identified and paid for does not, in fact, attend the Key Leader Event, the money your club remitted will be applied to another student in need.

Thank you for the selfless service you faithfully continue to do for others – especially for children who are the most vulnerable among us. Whether your service bears the Kiwanis logo or not is of little consequence. It's your commitment to the young that matters most. Thank you for that.




Missoula Kiwanis: We're Nearing 100



Sidnev: When it's game time at Sidney High School, it's Kiwanis Club time for the Sidney organization.

For the past 20 years, Sidney Kiwanis Club members have sold and taken admission tickets at the local high school's athletic events. The club stepped into the role after Sidney's teachers decided they no longer wanted to handle the duties.

Ticket taking has become one of the main fundraisers for the Sidney club. At the end of the fall and winter sports seasons, the high school pays the club based on how many shifts were worked by Kiwanians.
