


Friday Night Dinner Story Mansion August 6th 6:00 p.m. By Car Pool



The 106-year old Story Mansion—one of only three remaining city-block mansions in Montana—has long reigned as the grandest in town. Built in 1910 by T.B. Story, son of local cattle and gold magnate Nelson Story, the 22-room mansion was designed by architect C.S. Haire, who also designed Montana's state capitol. But just 12 years after Story built his home, which incorporates Queen Anne Victorian, Tudor, and Craftsman styles, he sold it due to a dwindling fortune. The buyers were the Sigma Alpha Epsilon (SAE) fraternity of Montana State University, which owned


Story Mansion until 2003. The Bozeman city commission allocated more than one million dollars to purchase Story Mansion, its carriage house, and the entire city block. Since opening to the public in 2009, Story Mansion has hummed with tours, holiday teas, a public Halloween party, weddings, a film festival and jazz performances. Proceeds from the mansion's rentals go toward ongoing maintenance to restore the second and third floors, which it hopes will become offices for educational and cultural institutions.





In the United States, Kiwanis clubs are required to file one of three Form 990 reports.

- Small, tax-exempt organizations whose gross receipts normally are US \$50,000 or less are required to file the IRS' electronic postcard Form 990-N.
- Those whose gross receipts normally exceed US\$50,000 to US\$200,000 are required to file Form 990-EZ.
- Those with gross receipts greater than \$200,000 must file Form 990.

It's easy to file your club's Form 990, but here are a few tips:

- 1. Find your club's status on the irs.gov or the Urban Institute's National Center for Charitable Statistics website.
- 2. Click on your state.
- 3. Put "Kiwanis" in the "Name" field.
- 4. Do not fill out the "Location" field.
- 5. Select "All Organizations" in the "Organization Type" field.
- 6. Check the "Limit to organizations in danger of revocation" box. Do not fill out the "NTEE purpose/activity code."
- 7. Click submit.

The IRS website also includes a helpful collection of tools and resources. Kiwanis International does not have records of your club's IRS history, but you can contact the Kiwanis International Office's Finance Department by email at finance@kiwanis.org or call 800-549-2647, ext. 153 or 146.

YOUTH PROTECTION

Nothing is more important than the safety of those we serve. That's why Kiwanis is committed to protecting children-and your club members. Kiwanis clubs around the world will focus on member education, important safeauards and more.

Get informed. Get inspired. Get ready by taking a look at the details below!

KIWANIS YOUTH PROTECTION GUIDELINES

Kiwanis youth protection guidelines are reviewed each year by the Kiwanis International Board. As a result, the guidelines are revised periodically to ensure Kiwanians adhere to the best practices of youth protection. Each member of your Kiwanis club should be provided with a copy-every year.

EDUCATION

Train members on youth protection at that week's Kiwanis club meeting. After completing the training, you and your club members should be able to:

- Understand the youth protection guidelines.
- Protect the youth you serve—and yourselves.
- Identify troubling behavior or abuse.
- Respond appropriately if a child discloses abuse to you or if you witness troubling behavior.

You have a couple of options for training:

- 1. For the facilitator of training at a club meeting, the PowerPoint, facilitator guide and handout are easy to use, providing a guide that helps walk through the policies with members.
- 2. Individual members can get the online Youth Protection Training. (This is also an effective way for the training facilitator at a club meeting to prepare.)

Once the training is completed for the Kiwanis year, the Kiwanis secretary should indicate this on the Kiwanis One dashboard.

CRIMINAL HISTORY AND BACKGROUND CHECKS

In addition to annual education regarding the Kiwanis Youth Protection Guidelines, each Kiwanis-club advisor to each Service Leadership Program your club sponsors (K-Kids, Builders Club, Key Club, Circle K and/or Aktion Club) must have a clear criminal history background check.

Your Kiwanis club's leadership determines eligibility requirements, as well as the provider of the background check. An easy option is to use Safe Hiring Solutions, the preferred provider for Kiwanis International. Once a clear background check is provided to the Kiwanis club secretary, he or she will indicate this on the KiwanisOne dashboard.

Your club's efforts during Youth Protection Week are important to the commitment that all Kiwanians must share. Thank you for strengthening the Kiwanis family's continuing status as a leader in building the next generation of service.

JANUARY MEMBERSHIP REPORT

The attached numbers are as of the end of December 2015.

As always, there is good news and some potentially bad news in this report.

First, the District is up 28 members! That is great, of course, but not great enough. To cover the usual 100 to 120 member drop when clubs purge their membership rolls in September, we need 10 to 12 additions monthly or 40 to 48 by the End of December. And Governor Bill has asked clubs to add one new member per month. Four clubs are on that track – huge congratulations to Malta, Missoula-Sentinel, Lewistown, and Helena!! If your club is not doing as well, I suggest you contact the leadership in these clubs – they know how to do it!

Second, Montana is second in Kiwanis International for the percentage of clubs adding at least one member 46%! Let's make a strong effort to push that number toward 100%!

Next 13% of our clubs are growing and 30% are not losing. 77% of the districts are growing. This is not the vibrant growth we seek, but if shows that the potential for breakthrough is there.

The bad news is that 23% of the clubs are in the caution zone (less than 25 members) where the potential for closing is markedly higher than for clubs with above 25 members. And, more worrisome, 35% of the clubs are in the danger zone (less than 15 members) where closure can be only one adverse event away. Two of our divisions are down in overall membership so far this year.

Looking at your club's numbers can be a wake-up call. If you are small and getting smaller – very bad news! If you are small and just holding on -bad news! Even in large clubs, a downward trend can tell you that something is wrong.

Membership is actually pretty simple:

- The club and its leadership needs to make membership a priority.
- A strong leader must be in charge of membership with an active committee.
- A plan must be in place that identifies who you would like to have as members, how to recruit them, and who will do it.
- · Review the progress of the membership committee in fulfilling the plan at least monthly.

Membership is not the reason for Kiwanis, but without members who have a fire in their tummy for serving their community and the children of the world, it just won't happen. Take care of the basics and the members will take care of the service.

Remember that the District Formula Committee is ready and very willing to assist divisions or clubs who want to address membership issues.

And, as always, the great things your club does for our communities and the children of the world is both humbling and inspirational.

Your club secretary should have recently received the request form. We so appreciate the clubs help in this effort. Your contribution does make a difference.

As we continue to support needs of our SLP's and our District clubs, we would like to encourage contributions to the foundation to allow the foundation to stay strong financially so needs can be met. Our foundation is a 501(c)(3) charitable organization which allows your contributions to be tax deductible. THE ELIMINATE PROJECT

Phase Two has started!

The Eliminate Project started five years ago as Kiwanis International's pledge to raise \$110,000,000 to fund UNICEF's ongoing effort to rid the world of Maternal Neo-Natal Tetanus (MNT). At that point this major killer of new babies and their mothers took a baby's life every 9 minutes plus many mothers when tetanus was contracted during child birth. The project's aim was to vaccinate every woman of child bearing age in countries the World Health Organization classified as at risk.

In the ensuing five years Kiwanis has raised over \$104,000,000 in contributions and pledges with up to \$2,000,000 yet to be completed. 20 some countries have been declared MNT free, with only 20 more to go. We are on the verge of Eliminating a major killer of children worldwide – for the second time.

The remaining amount will certainly come in. But that is Kiwanis International's problem. In Montana we have committed to our fair share as a District. Fair share means \$110,000,000 divided by the number of Kiwanians – or about \$500 per member over the next five years. To date we are right at \$300,000 given or pledged of which about \$29,000 are pledges still being filled. That leaves the Montana share of fulfilling the Kiwanis International pledge at about \$350,000 over the next five years.

That, of course, is a large number, but if you look at it in pieces it becomes less daunting. We have five years to complete this task – or \$70,000 a year. That breaks down to \$61 per member raised per year. If our Service Leadership Clubs contribute over the next five years as they have in the past five, that number will be reduced to \$54 per member per year. That seems very "doable" to me.

Note that I said raised not given. Although we can anticipate that the big hearts of Montana Kiwanians will result in deep personal pockets, I really hope that we can raise a substantial part of this commitment from fund raising events and gifts from non-Kiwanians. Other people deserve the opportunity to become part of this world changing event too. And I do not need to tell Kiwanians how to raise money for children around the world – that is what we do better than anyone else. We just need to set our mind to it and it will happen.

Please spend a little time as 2016 starts to consider what level of support you as individuals and as Kiwanis Family Clubs will commit to. Then let me know so I can keep track of where we are – and help members/clubs build plans to make this dream come true. Please don't procrastinate. Women and new babies around the world are, in desperate hope, awaiting the Kiwanis bought vaccine – at \$1.80 each.

As always, thanks for all you do. It is humbling and inspiring to see what Kiwanis accomplishes each day – in our communities, our District, and around the world – one child at a time.
